#### Presidents Corner - Mark Sternitzke

This is Mark Sternitzke and I'm in my second year as President for the Carriage Hills HOA

Earlier this year, Brian Hix and I attended a HOA Legal Clinic sponsored by the cities of Plano, Garland, and Rowlett. The clinic featured speakers from the various cities, as well as lawyers specializing in HOA's and real estate. Many sessions focused on topics related to mandatory associations. As CHHA is a voluntary association, these sessions did not apply to us.

One session towards the end of the clinic did catch my attention. The topic dealt with property covenants and restrictions. The speaker stated that if neighborhood property covenants and restrictions are registered with the county, those covenants are bound to the properties in the neighborhood. Property owners are obligated to abide by the covenants, regardless of whether you were told about the covenants or not at the time of the purchase.

You can see the Carriage Hills Covenants & Restrictions by visiting the Collin County web site. Click on the County Clerk link, the Deed Search link, and enter "Carriage Hills" in the search widget. Three sets of covenants are registered, one for each new phase of Carriage Hills.

The last version of the covenants registered with the county is dated March '90. An amendment was added to the Carriage Hills Covenants & Restrictions following the completion of the Phase 3 buildout. The amendment states that the Covenants & Restrictions may not be amended, revised, or abolished for a period of five years. This time period has long since expired. Following this five-year period, the Covenants & Restrictions can be amended, revised, or abolished only if 75% of the owners of record sign an appropriate written instrument and this instrument is recorded with the county.

Are our Carriage Hills Covenants & Restrictions still valid? I'm not sure. I called the county and talked with a clerk from the Land Records department. She cannot tell me one way or the other. I turned to the University of Google for help. For every website that states covenants never expire, there is another that states covenants expire after 15, 20, etc., years. I'm not a lawyer so I'm not commenting one way or the other.

What I do know is that the covenants are put in place to enhance the value of our property. I hope everyone reading this article would visit the Carriage Hills website and spend 15 minutes reading the Carriage Hills Covenants and Restrictions document. If everyone in the Carriage Hills lives up to the intent of the document, Carriage Hills will continue to be one of Plano's premiere neighborhoods.

As we are about to turn the page on 2023, I hope everyone has a healthy, safe, prosperous, and wonderful 2024.
